Check in is at the Grand Lodge located at 6 Emmons Rd. in Mt. Crested Butte. Check in is guaranteed at 4 pm on the day of your arrival. If you arrive prior to 4:00pm, an early check-in may be available depending on hotel occupancy.

Check Out: Check out is at 11am on the day of your departure. Late check out is available on a request basis.
